I (we) understand and agree that if at any time during the Event I (we) should become dissatisfied with one or more of the Contract Professional Sitter(s) assigned by Seeking Sitters, I (we) can contact SeekingSitters and request an alternative assignment.

Hold Harmless

In consideration of SeekingSitters' agreement to provide one or more Contract Professional Sitter(s) for the Event, I (we) on behalf of myself (ourselves) and the Minor(s), as well as our respective heirs, assigns, administrators, personal representatives, and next of kin, do hereby release and hold harmless SeekingSitters, the Contract Professional Sitter(s) assigned to the Event, and their affiliates, subsidiaries, agents, assigns, employees, representatives, officers, directors, and shareholders (hereinafter the "Releasee's") from any and all liability, damages and/or claims for injury or death to persons or damage to property arising from any and all actions or omissions of any and all persons or entities at the Event, including (but not limited to) those injuries and damages caused by Releasee's alleged or actual negligence, and further agree to waive any and all right, title, claim, cause of action or property interest of any kind which may arise out of or be related to my (our) or the Minor(s)' attendance and/or participation in the Event. I (we) further agree to defend and indemnify the Releasee's from any and all claims of the undersigned and/or a third party for injury to person(s) and/or damage to property which may be caused by or result from actions or omissions committed by myself (ourselves) or the Minor(s).

Responsibility

I (we) hereby authorize the Contract Professional Sitter(s) assigned to the Event to act according to their best judgment in any situation requiring medical attention related to the Minor(s), whether an emergency or not, until such time as I (we) can be contacted and permitted to make decisions regarding medical treatment.

I (we) further agree and understand that this Waiver and Release is intended to be as broad and as inclusive as is permitted by applicable law, and that if any portion of this Waiver and Release is held invalid, the remaining portions will continue in full legal force and effect. I (we) acknowledge having read this Waiver and Release and voluntarily signed same, and further acknowledge and agree that neither Seeking Sitters, nor any of the Releasee's, has made any oral representations, statements or inducements apart from the statements contained in this Waiver and Release. Anyone executing this Waiver and Release is urged to consult an attorney regarding the effect of agreeing to the terms hereof.
